SHORT QUESTIONS

1. What do you mean by surface charge density and write its SI unit?

Ans.—Surface charge density—It is defined as charge per unit area. It is denoted by σ .

It can be expressed as,
$$\sigma = \frac{Q}{A}$$

The S.I. unit of σ coulomb / metre² (cm⁻²).

2. The vertical component of earth's magnetic field at a place is $\sqrt{3}$ times the horizontal component. What is the angle of dip at this place?

Ans.—We know that,

$$\tan \theta = \frac{V}{H}$$

Where ' θ ' is the angel of dip, According of question it is given

that,
$$V = \sqrt{3}H$$

$$\therefore \tan \theta = \frac{V}{H} = \sqrt{3}$$

$$\therefore \tan \theta = \sqrt{3}$$
So, $\theta = 60^{\circ}$

3. Give two applications of ultra-violet waves.

Ans.—Two applications of ultra-violet waves are as follow—

- (i) They are used to preserve food stuff and make drinking water free from bacteria, as these rays can kill bacteria, germs etc.
- (ii) They are used for stirlizing the surgical instruments.
 - **4.** State Ampere's circuital law. Express it mathematically.

Ans.—It states that—"Line integral of magnetic field 'B' around any closed path is free space is equal to absolute permeability ' μ_0 ' times the net current 'I' enclosed by the path.

Mathematically, it can be expressed as—

$$\oint \vec{B} \cdot \vec{dl} = \mu_0 I$$



5. A wire of resistance 10Ω is stretched to double its length. What will be its new resistance?

Ans.—
$$R = p \frac{l}{A} = p \frac{ll}{Al} = \frac{p}{V} l^2$$

V is volume which does not change in stretching.

$$\therefore \frac{R_2}{R_1} = \frac{l_2^2}{l_1^2} = \frac{(2l_1)}{l_1} = 4$$

$$R_2 = 4R_1 = 4 \times 10 = 40 \Omega$$

6. State Brewster's law. Express it mathematically.

Ans.—Brewster's law—It status that, the refractive index of the refractive medium (n) is numerically equal to the tangent of the angle of incident (i_B) for which reflected ray is polarised.

Mathematically, it can be expressed as—

$$n = \tan i_B$$

7. Derive the expression for de-Broglie wavelength?

Ans.—According to quantum theory, the energy of a photon is given by, E = hv ...(i) According to Einstein is relation between Energy (E) & momentum p.

$$E = \sqrt{p^2 c^2 + m^2 c^4}$$

Photon is mass less $(m_0 = 0)$

$$\therefore \qquad E = pc$$

we have

$$hv = pc$$

$$p\frac{h}{\left(\frac{c}{\lambda}\right)} = \frac{h}{\lambda} \qquad \dots (ii)$$

Relation (ii) in for wave (photon)

According to di Broglie if a wave behave like a particle, then a particle (matter) must behave like wave of wavelength.

$$\lambda = \frac{h}{p} \qquad \dots \text{(iii)}$$

8. The powers of two lenses are +12D and -2D. They are placed in contact coaxially. What will be the focal length of the combination?

Ans.—We know that,

Power of combination, $P = P_1 + P_2$

Here according to question $P_1 = +12$, $P_2 = -2D$

:. Focal length of the combination is given by,

$$f = \frac{1}{p}$$

$$= \frac{1}{10} \text{ m}$$

$$= \frac{1}{10} \times 100 = 10 \text{ cm}$$



- **Ans.**—'LASER' stands for light Amplication by stimulated emission of radiation.
 - 'MASER' stands for microwave Amplication by stimulated emission of radiation.
- 11. If the maximum amplitude of the AM wave is 12V and the minimum amplitude of this wave is 4V, find the modulation index is percentage.

Ans.—Given that,

$$\begin{aligned} E_{\text{max}} &= 12V, \\ E_{\text{min}} &= 4V, \end{aligned}$$

$$\therefore m_a = \frac{E_{\text{max}} - E_{\text{min}}}{E_{\text{max}} + E_{\text{min}}}$$

$$=\frac{12-4}{12+4}$$

$$=\frac{8}{16}$$

$$m_a = \frac{1}{2}$$

12. With the help of mean and labelled diagram explain the working principle of a transformer. Mention different types of losses in a transformer?


Ans.—Transformer—Transformer is a device which converts low alternating voltage at high alternating current into high alternating voltage at low alternating current and vice versa.

It does not work on D.C.

Principle—It works on the principle of "mutual induction". It states that if magnetic changes in primary coil then *EMF* is induced in secondary coil and vice versa.

Construction

Working

In a transformer these are two types of coil: Primary and Secondary.

Primary coil is attached with input whereas secondary coil is connected to output.

Through induction alternating voltage may be increased or decreased. It works on the "Coupling Method". Theory

According to law of Faraday

$$\frac{d\phi}{dt} = -E \tag{i}$$

Flux changes in the coil is directly proportional to the no. of turns in the coil

eqⁿ is called working theory of a Transformer upto here only

 is called Transformation Ratio

It is represented by k

$$K = \frac{N_s}{N_p} \qquad \dots \text{(vi)}$$

If K > 1, then transformer is step-up Transformer.

If k < 1, then transformer is step-down Transformer.

Types of Transformer

Step-up Transformer—A transformer is said to be step-up if low alternating voltage at high alternating current is converted into high alternating voltage at low alternating current.

In a step-up transformer, no. of turns in secondary coil is larger than no. of turns is primary coil.

i.e.
$$N_s > N_p$$
 ...(A)

Step-Down Transformer—Transformer is said to be step-down transformer if it converts high alternating voltage at low alternating current into low alternating voltage at high alternating current.

Number of turns in a primary coil is larger than no. of turns in a secondary coil.

i.e.
$$N_p > N_s$$

Uses of Transformer

- (i) A step-down transformer is used for the purpose of obtaining large electric current for electrical welding.
- (ii) A step-down transformer is used in the Induction-furnace for melting the metals.
- (iii) A step-up transformer is used for the production of X-ray.
- (iv) Transformer are used in voltage-regulator and stabilizer.
- (v) Small transformer are used in radio-sets, television, telephones and loud speakers.

Different Types of loses in transformer

Flux loss—The linkage of primary to secondary coil is neither ideal nor perfect. Hence, whole of the magnetic flux produced in primary coil never gets linked up with the secondary coil. Hence some of the energy is lost in the form of flux, known as flux loss.

Copper loss—Due to resistance of the windings in primary and secondary coil, it opposes the current to pass through it when current passes through the coil heat is produced. Due to heat, energy is lost which is called 'copper loss'.

Iron loss—Due to the variation in magnetic flux, eddy current is produced in the core of a transformer. When current passes through resistance, small heat is produced due to Eddy current. Hence small amount of energy is lost due to heat, known as Iron loss.

Hysteresis loss—The alternating current passed through the coil which is magnetic in behaviour. During each cycle of AC, magnelisation and demagnetisation is the result. Due to this hysteresis loop, energy is lost which is called Hysteresis loss.

Humming loss—When alternating current is passed through the core of wise, it starts vibrating. Due to vibration, sound is produced, hence same amount of energy is lost in the form of sound, which is called 'Humming loss'.

Efficiecny the ratio of output powr to the input power

Mathematically it can be written as:

$$\eta = \frac{P \text{ output}}{P \text{ input}} \qquad \dots (1)$$

Due to different types of losses, such as flux loss, copper loss, Iron loss, hysteresis loss and humming loss, output power is always less than input power.



Conclusion: Efficiency of a transformer is always less than 100%

13. Explain Biot-Savart law. With its help derive an expression for the magnetic field at any print on the axis of a current carrying circula loop?

Ans.—Bio-Savart's Law



Bio-Savart's Law is the basis law of electricity and magnetism it is used to find the small magnetic field due to current carrying wire.

It states that small magnetic field (dB) due to current carrying element is

I. directly proportional to the electric current passed through the wire

i.e.
$$dB \propto I$$
 ...(i)

II. directly proportional to the small length (dl)

i.e.
$$dB \propto dl$$
 ...(ii)

III. directly proportional to the sine of angle between current carrying wire and given point.

i.e.
$$dB \propto \sin \theta$$

IV. inversly proportional to the square of distance between current carrying wire and given point.

i.e.
$$dB \propto \frac{1}{r^2}$$
 ...(iv)

Combining eqⁿ(i), (ii), (iii) and (iv)

$$dB \propto \frac{Idl\sin\theta}{r^2} \qquad \dots (v)$$

$$dB = \frac{\mu_0}{4\pi} \cdot \frac{Idl \sin \theta}{r^2}$$

Eq¹¹(vi) is scalar form of Biot-Savart's Law.

Where, $\frac{\mu_0}{4\pi}$ is a proportionality constant.



Let us consider a circular current carrying verticle circle as shown in the figure. The radius of circular current carrying loop is we want to calculate total magnetic field at point P which is x distance away from at centre.

There are two components of Magnetic field dB. Each and Every $\overrightarrow{dB}\cos\theta$ component cancelled by each other. Due to its counter part.

$$B = \overrightarrow{dB} \cdot \sin \theta \qquad \dots (1)$$



14. What do you mean by Photoelectric effect? State and derive Einstein's Photoelectric equation?

Ans.—Einsteins photoelectric equation establish the 'Particle Nature' of electron. It is based on conservation of energy.

Einstein received Noble prize for photoelectric equation.

Statement—"Total incident energy of light is used into two forms, same part of the energy is used as a work function and remaining part of the energy is used as a kinetic energy of photo electrons."



Mathematically, Einstein equation can be written as,

Incident energy = Work functions + Kinetic energy
$$\dots(1)$$

$$E = \phi + K$$

$$\therefore \qquad \boxed{K = E - \emptyset} \qquad \qquad \dots (2)$$




15. State and explain refraction through convex spherical surfaces.

- 2. The object must be lie on the principle axis. The object is point object.
- 3. The angle made by object image and normal must be very-very small.

1. Define electric field intensity and write its SI unit with dimension also.

Ans.—The electric field intensity due to a source charge at any point in its electric field is defined as the force experienced by a unit positive charge placed at that point.

Mathematically, it can be expressed as

$$\overrightarrow{E} = \frac{\overrightarrow{F}}{q_o}$$

The S.I. unit of electric field intensity is newton/coulomb

it NC⁻¹ or volt/ metre

The Dimesion of electric field intensity is,

$$[E] = \frac{[F]}{[q]} = \frac{[F]}{[It]} = \frac{[MLT^{-2}]}{[AT]} = [MLT^{-3}A^{-1}]$$

2. What is the function of 'moderator' and 'Controlling rods' in a nuclear reactor?

Ans.—Function of moderator is nuclear reactor—

It slows down the speed of neutrons to make them useful for further fission.

Function on controlling rods is nuclear reactor—

It absorbs the excess no. of neutrons which are produced in reactor.

3. Welders wear special goggles or face masks with glass windows to protect their eyes from electromagnetic radiations. Name the radiations and write the range of their wavelength.

Ans.—ultraviolet rays.


The wavelength of UV rays is 400 nm to 1 nm.

4. Define the activity of a given radioactive substance. Write its S.I. unit.

Ans.—The total decay rate of a radioactive sample is called the activity of the sample.

The S.I. unit of activity is 'becquerel'.

5. Calculate the capacitance of the capacitor C. The equivalent capacitance of a combination between P and Q is 30 μ F.



Ans.—Capacitors C_1 , C_2 and C_3 are in parallel, so the equivalent capacitance of these capacitors are

$$C' = C_1 + C_2 + C_3$$

= $20 + 20 + 20$

$$=60\mu F$$

Then, C and C' are is series, so equivalent capacitance, C" is given by—

$$\frac{1}{C''} = \frac{1}{C} + \frac{1}{C'}$$
 But C'' = 30µF

$$\therefore \frac{1}{30} = \frac{1}{C} + \frac{1}{60}$$

or,
$$\frac{1}{C} = \frac{1}{30} + \frac{1}{60} = \frac{2-1}{60} = \frac{1}{60}$$

$$\therefore C = 60 \mu F$$

6. Why the core of a transformer is laminated?

Ans.—The core of a transformer is laminated to reduce the energy loss due to eddy currents. Laminations break the path of eddy currents. The energy loss due to eddy current also results in unnecessary heating of the transformer which may be harmful for the winding of the transformer.

7. The radius of curvature of the forces of a double convex lens are 10 c.m. and 15 c.m. If focal length of the lens is 12 c.m., field the refractive index of the material of the lens.

Ans.—Given that,

$$R_1 = 10 \text{ c.m.}$$

$$R_2 = -15c.m.$$



Sensitivity of a Galvanometer

A galvanometer is said to be sensitive if small current or voltage change produces large deflection in current. There are two types of sensitivity:

- (1) Current Senstivity
- (2) Voltage Senstivity



Conversion of MCG into Ammeter

An ammeter is a device that measure current in the electric circuit. For an ideal ammeter, resistance is almost zero. A MCG can be converted into an ammeter by connecting a low resistance called 'Shunt Resistance' connected in parallel with MCG.


Huygen's principle gives the geometrical details of travelling of a wave. This principle is used to find the position of the given wavelength at any instant of time.



Following are the important assumption made by Huygen's—

- 1. Each source of light is the centre of disturbance from which waves spread in all direction.
- 2. Every point on a wavefront is a source of new disturbance which produces secondary wavelength.
- 3. Only forward envelope enclosing the tangent at the secondary wavelength at any instant gives the new position of wavefront.

Laws of Refraction by Using Huygen's Principle

Let us consider a plane wavelength AB. According to Huygen each and every point on the plane wavefront is the source of secondary disturbance which propagates in all the direction XY is the refracting surface. When a ray of light passes from Rarer to denser medium it bends toward the normal.






13. Explain transistor as a switch and transistor as an amplifier?

Ans.—Transistor as a Device—Transistor can be used as a switch when it operators in cut off region (open switch) and saturation region (closed switch). On the other hand, transistor is used as an amplifier to increase the magnitude of the output signal when it operators in the active region.

(I) Transistor as a switch—A device which turns ON or OFF electric current in an electric circuit is known as a switch. A transistor acts as a switch when it is driven back and forth between saturation and cut off regions. Circuit diagram showing transistor as a switch is shown in figure.







When base input voltage V_{BB} is very low so that the transistor is not forward bias, then no current flows through R_{C} i.e. $I_{C} = O$ Hence, the output voltage $= V_{CC}$. The transistor is in the cut off mode and acts as an open switch i.e. OFF state. When base input voltage is enough positive, the transistor is forward biased. Therefore, the current I_{C}


flows through R_C . In this situation, voltage drop across $R_C = V_{CC}$. Hence, $I_C = \frac{V_{CC}}{R_C}$ and $V_{CE} = 0$ Therefore the transistor acts as a closed switch i.e. ON state.

Transistor as an amplifier—A device which increases the amplitude of the input signal is called amplifier.

The weak input signal (i.e. a signal of small amplitude) is fed to the amplifier which is turns amplifiers it and we get output signal or large amplitude.



The basic circuit of β np transistor amplifier in common base configuration is shown in figure.

Transistor is biased in the active region i.e. emitter-base junction is forward biased with a battery V_{EE} and the collector-base junction is reverse baised with a battery V_{CC} . The emitter-base circuit is known as input circuit and the collector-base circuit is known as output circuit. The signal voltage V_s to B_e amplified is fed to the input circuit. The output is taken across load resistance R_L in the output circuit. When signal voltage V_{EE} , then input voltage V_i is increased to ΔV_i . Due to this increased voltage, emitter current increases by ΔI_a . This will Increase the collector current by $\Delta I_{\rm C}$. Therefore, the output voltage across RL will increase to $\Delta V_{\rm C}$, Where,




Output Characteristics of Common Emitter Transistor

The variation of the collector current $I_{\rm C}$ (output) with collector-emitter voltage ($V_{\rm CE}$) at constant base current ($I_{\rm b}$) is called output characteristic.

Conclusion—

- For a given value of base current, collector current increases rapidly with the collector-emitter voltage in the begining but at high value of V_{CE} , collector current becomes constant.
 - For a given value of V_{CE} , the collector current (I_{C}) is higher for high value of base current (I_{b}) .

Output resistance (r_0) is defined as the ratio of small change in V_{CE} (i.e. ΔV_{CE}) to the small change in collector current (ΔI_c) at constant base current.

Output characteristics of a transistor in common-emitter configuration are divided into three regions:

- active region, (i)
- (ii) cut off region and (iii) saturation region

Active region—Active region lies above $I_B = 0$ as shown in figure. In this region, collector junction in reverse biased and emitter junction in forward biased for a given value of IB, collector current increases as / VCE / increases. A transistor is operated in active region if it is used as an amplifier.\

Cut off region—Cut off region lies below IB = 0. The collector current has finite value under this condition. In order to cut off the transistor, the emitter junction has to made slightly reverse biased in addition to IB = 0.

Saturation region—Saturation region lies close to zero voltage axis where all the curves coincide. In this region, collector current is independent of the base current.

Current Amplification factor (β) :

(i) d.c. current gain (βdc)—

It is defined as the ratio of the collector current (I_e) to the base current (I_B). That is $\beta dc = \frac{I_C}{I_B}$

Since $I_C > I_B$, so βdc is greater than 1. The value of βdc lies between 20 and 200.

(ii) Small signal current gain (βac)—

It is defined as the ratio of small change in collector current (ΔI_C) to the small change in base-current (ΔI_B) at constant collector-emitter voltage (V_{CE}).

14. Explain p-n junction diode as a full wave rectifier?

Ans.—**Junction Diode as a full wave rectifier**—Full wave rectifier rectifies both halves of a.c. input signal. The circuit diagram of full wave rectifier as show in figure 16.






The a.c. input signal is fed to the primary (p) coil of the transformer. The p-regions of both the diodes D_1 and D_2 are connected to the two ends of the secondary coil (s). The load resistance R_1 across which output voltage is obtained is connected between common point of n regions of diodes and central tapping of the secondary coil.

Working—When positive half cycle of input a.c. signal flows through the primary coil, induced e.m.f. is set up in the secondary coil due to mutual induction. The direction of induced e.m.f. is such that the upper end of the secondary coil becomes positive while the lower end becomes negative. Thus, D_1 is forward biased and diode D_2 is reverse biased, So the current due to diode D_1 flows throught the output voltage which varies in accordance with the input half cycle is obtained accross the load resistance (R_1) .

During negative half cycle of input a.c. signal, diode D_1 is reverse biased and diode D_2 is forward biased. The current due to diode D_2 flows through the circuit in a direction shown by arrows (below R_1). The output voltage is obtained across the load resistance (R_1).





The direction of eddy currents is given by Lenz's law.

Correction—It is corrected by "bifocal lens". Upper part is concave lens & power part is convex lens.





CONSTRUCTION OF AN HUMAN EYE







14. Explain Faraday's law of electromagnetic induction and discuss Lenz correction.

Ans.—Law of Electromagnetic Induction

1. **First law**—Whenever there is change in magnetic flux linked with the coil changes induced emf produced in the coil.

The induced emf lasts as long as the change in magnetic flux linked with the coil.

2. Second law—Rate of change of magnetic flux linked with the coil is directly proportional to the induced emf.

The direction of emf was calculated by lenz. The corrected form is called Faraday lenz law.

Faraday-lenz correction—Hence, emf induced in the coil opposes its cause, In other words direction of emf is opposite to change in magnetic flux takes place in the coil.

The magnetic of induced emf in a circuit is equal to the time rate of change of magnetic flux through the circuit. Mathematically, the induced emf is given by

The negative sign indicates the direction of E. In case of a closely wound coil of N turns, change of flux associated with each turn, is the same. Therefore the expression for the total induced emf is given by

The induced emf can be increases by increasing the number of N turns of a closed coil.





Ans.—A.C. Generator—Generator is a misnomer in physics, it generates nothing but it is a converter.

Generator is an electrical device which is used to convert mechanical energy into electrical energy.

Principle—It works on the principle of electromagnetic induction. When a coili s rotated in a uniform magnetic field induced emf is produced.

Components—There are is components in a generator.

- (i) Armature—It is a coil is which large number of turns are present. It is rectangular in shape. The wire is made up of insulated copper wrapped around soft iron core.
- (ii) Field magnet—The main function of field magnet is to produce large magnetic field. Parmanent magnet or electromagnet may be used for this purpose but their strength must be very large. The rectangular coil is placed in between two magnet.
- (iii) Slit Rings— R_1 and R_2 are two slip rings. It is attached with the armature cool. As coil rotated slip rings also rotates.
- (iv) Carbon Brushes— B_1 and B_2 are two carbon brushes. It is compressed with the coil, as coil rotated it is not rotated. These brushes are connected to the load through which output can be obtained.

14. Explain the application of p-n junction diode as rectifier.

Ans.—APPLICATION OF p-n JUNCTION DIODE AS RECTIFIER

A device which converts alternating current (a.c.) into direct current (d.c.) is known as rectifier.

The process of converting a.c. into d.c. is known as rectification.


Principle—Junction diode conducts only when forward biased and it does not conduct when reverse baised.

This fact makes the junction diode to work as a rectifier.

Junction diode as a half wave rectifier.


The rectifier which converts only one half of a.c. into d.c. is called half wave rectifier.

The circuit diagram of half wave rectifier.



Working—When positive half cycle of input a.c. signal flows through the primary coil, induced e.m.f. is set up in the secondary coil due to mutual induction. The direction of induced e.m.f. is such that the upper end of the secondary coil becomes positive and lower end becomes negative. Since upper end of secondary coil is connected to p-region and end is connected to the n-region of the junction diode, so the junction diode is forward biased during the positive half of input a.c. Thus the junction diode conducts and flow of current starts in the direction shown by arrows. The output voltage which varies in accordance with the input half cycle is obtained across the load resistance R_1 .

When negative half cycle of a.c. input flows through the primary coil, again induced emf is set up across the secondary coil due to mutual induction. Now the direction of induced emf is such that upper end of the secondary coil becomes negative and lower end becomes positive. So the juction diode is reverse baised. Hence the junction diode does not induct and therefore. We got no output across the load resistance during negative half of input and corresponding output voltage are shown in figure.



Since only half of the portion of the wave (input signal) is obtained as output in the form of d.c., so the junction diode is called a half wave rectifier.

Disadvantae

- 1. Since the output signal is discontinuous, so the efficiency of half wave rectifier is small.
- 2. The output is not d.c. but it is a fluctuating for pulsating (d.c.) which contains a.c. components or expression for output d.c. voltage

output d.c. voltage = mean load current \times load resistance

i.e.

15. Explain with the help of neat & labelled diagram the principle of Davison & Germer experiment.

Ans.—Davission and Germer Experiment—

Davission and German experiment established the wave nature of electron. They use the deflection effect of electron radiation scattered by the crystals.

Following are the important components of experimental set up—

- 1. Electron gun
- 2. Nickel crystal
- 3. Movable detector or collection.
- 1. Electron Gun—The main function of electron gun is the supply of electron. Electron is supplied by the filament made up of Tungsten. For controlled emission of tungsten, filament is coted with Barium oxide. The filament acts as an Emitter. Electron gun is heated with low tesnion wire.
 - 2. Nickel crystal—It behaves like linear scale. All electrons emitted by electron gun is collected by the



Nickel cyrstal and scattered in all the direction.

3. Movable Dectors or collector—The main function of collector is to collect all the electron scattered by the Nickel crystal. It is connected Galvanometer, So that catching of electron can be detected.





13. State and explain interference of light. Find conditions for constructive & destructive interference. Also find its expression.

Ans.—Interference of Light—Interference is the superposition of two light waves due to which non-uniform distribution of energy takes place in the medium. Due to interference of two light waves redistribution of energy takes place in the medium. The points at which intensity of light is maximum is called constructive interference while at some points in the medium at which intensity is minimum is called distructive interference. Constructive interference is also called Bright fringes. Destructive interference is also called Dark fringes.

The constructive pattern of constructive interference and destructive interference pattern of light. If interference pattern is permanent on the screen then it is called sustained interference pattern. Following are the important conditions for sustained interference pattern—

- 1. The two light source emits light wave continuously.
- 2. The two light source must be very-very close to each other.
- 3. The light wave should be of nearly same wave length.
- 4. The intensity of light of two source must be nearly same.
- 5. The two light source must be in same phase or constant phase.
- 6. The light source must be narrow.

CONDITIONS FOR CONSTRUCTIVE AND DESTRUCTIVE INTERFERENCE





We want to calculate electric field on axial line of electric dipole at point "P". Which is "r" distance away from the mid-point of the electric dipole.

 $\overrightarrow{E_1}$ is the electric field due to (-ve) charge which is acting inward. $\overrightarrow{E_2}$ is the electric field due to (+ve) charge which is acting outward.




